# § 1 Subject of the Contract

1. The subject of this contract is the following journal article, which is to be published in ZGD.

- 2. The authors ensure they are the only ones entitled to decide over the copyright of the work. Furthermore, the authors ensure they have not made any disposition that conflicts with the granting of rights under this contract. This also applies to the figures supplied by the authors, for which the authors have the rights of use. If the authors submit figures to the editors for which this does not apply or is not certain, they must inform the editor and be transparent about all the information that is legally relevant in this context. Furthermore, the authors assure that they have secured all title protection rights for the title of the work and that they have the rights of use for it. The authors confirm that the editor is not responsible for any recourse claims by third parties associated with infringements of rights.
- 3. The authors are obligated to notify the editor in writing if the work contains any depictions of people or events that might bear the risk of a violation of personal rights.

  If the work violates personality rights or if the authors fail to point this out, the editor is entitled



If the work contains extremist and/or national socialist and/or statements that glorify violence or distort historical events or developments, the editor has the right to withdraw from the contract with immediate effect.

# § 2 Granting of Rights

The authors grant the editor the following rights for electronic online publication (open access): the simple, non-exclusive, and permanent right of use. The editor is authorized to reproduce and store the work on ZGD's and HGD's homepage and to make it accessible electronically via national and international data networks.

If necessary, the editor is allowed to transfer the data into other formats, whenever required by technical development. The electronic publication will be archived and published online for as long as possible, as long as this can be achieved with reasonable effort.

## § 3 Duration of Contract

For electronic publications, the contract is concluded for an indefinite period of time.

## § 4 Expenses

The editor is responsible for the expenses of the production and distribution of the journal. Additional costs and expenses, for which the editor is not responsible, are to be paid by the authors.

#### § 5 Remuneration

The authors do not claim any remunerations or financial compensations of any kind.

## § 6 Data, Manuscript, Production, Proofs

- 1. The authors are required to provide the editor with the data and materials required for publication. This needs to be done in accordance with the editor's specifications. Deviations from these specifications that have not been clarified or agreed upon in writing in advance may lead to financial charges and may also affect timelines and dates.
- 2. Proofs are the property of the editor and only serve the purpose of final publication preparation. Authors will not publish proofs or use them for any other purposes than manuscript publication preparation. Authors will delete the proofs after manuscript publication.
- 3. For security purposes, the authors should always keep a copy of the manuscript.
- 4. Authors carry out proofreading and corrections without any financial compensation. The publisher is obligated to send the authors a legible draft of the finished proof. The authors are to check the draft immediately and notify the editor if the proof is "ready for printing"; this marking also approves any deviations from the manuscript. If the authors do not return proofs within the deadline the editor and authors have agreed upon, proofs are also considered "ready for printing".
- 5. Alternatively, complete proofs can be sent as a secured PDF. These do not provide any information about the final print quality. If no analog proofs shall be made, the costs for the production of proofs are not refunded.
- 6. If the authors make further changes in addition to orthographic corrections that were not agreed upon, e.g., to the typesetting or layout, the authors are required to cover any additional costs that might result from these changes.



# § 7 Rejection of Texts

The editor has the right to reject texts if the authors have not complied to the guidelines sufficiently and do not submit a modified version of the text within a reasonable period of time. The same applies if the authors do not submit their text in time.

# § 8 Additional Agreements

Additional agreements between the authors and the editor that go beyond this contract must be made in writing.

# § 9 Extraordinary Termination of Contract

- 1. Each party is entitled to terminate the contract on the basis of important reasons.
- 2. The editor retains the right to terminate the contract immediately if the published text of the authors contains politically extremist positions, elements that distort history, publicly offensive content, or disparagement of people. Likewise, the editor can terminate the contract immediately if the text violates national or international laws.
- 3. If the authors terminate the contract before its conclusion and notify the editor about the termination in writing, the editor is authorized to delete the work from their storage device 30 days after the termination of the contract at the latest. The work may continue to be made available to authorized users until it has been deleted from the storage device. § 5 shall apply accordingly.

### § 10 Contact Details

The authors are required to provide the editor with up-to-date contact information for the period of the duration of the contract (see § 3).

#### § 11 Final Provisions

If this contract does not clearly clarify the legal handling of a specific situation, the general statutory provisions of the law of the Federal Republic of Germany apply. Should any individual provision or any part of any provision be or become void or invalid, the validity of the remaining provisions shall in no way be affected. In this case, the parties are obliged to replace the invalid provision with a provision that is economically and legally as similar as possible to the invalid provision.
